

SPOTLESS SECURES CONTRACT WITH QGC

Spotless Group Limited (ASX/NZX: SPT) has been awarded an integrated village management contract to support the major LNG project for Queensland-based QGC Pty Limited, a local subsidiary of BG Group.

Spotless will maintain and manage assets and provide accommodation, housekeeping and catering services for up to 1,650 people working on the Curtis LNG project, living in the new SE QLD villages of Ruby Jo and Woleebee Creek.

The contract, worth approximately \$45 million, will create opportunities for businesses and workers in the regions as Spotless will seek local providers and personnel for delivery of goods and services wherever possible.

Josef Farnik, Spotless Group Managing Director and CEO, said Spotless was proud of the role it would play in supporting one of Australia's largest capital infrastructure projects.

"Spotless is very pleased to secure its first integrated management contract with QGC. It is an important addition to the company's growing portfolio of resources contracts," he said.

Key features of Spotless' QGC contract include:

- Accommodation management, catering and housekeeping services;
- Deploying a local network of tradespeople to work with Spotless staff to deliver village maintenance and repair services; and
- Developing recreational programs and leisure activities to encourage healthy lifestyles for staff outside their working hours.

Spotless expects to have more than 140 staff working on site when the villages are at full capacity. The contract commences in April 2012 to the end of 2014.
